AGE LIMITS (Age as of April 19, 2026):

Instrumental Contestants: Ages 13-26

Applicants must have/do the following to qualify:

- A video recording* submitted by the application deadline.
- The ability to compete in the Semi-Final Round at the University of Redlands on **Sunday, April 19, 2026**.
- The ability to compete in the Grand Finals on **Tuesday, June 23, 2026, between 6:00 p.m. and 10:00 p.m.**, as a part of a Redlands Bowl Summer Music Festival season performance.
- The ability to attend two mandatory rehearsals with the orchestra at the Redlands Bowl on **Sunday, June 21, 2026, from 8:00 p.m. to 11:00 p.m.** and **Monday, June 22, 2026, from 8:00 p.m. to 11:00 p.m.** *Applicants will also need to be available for a coaching session with piano accompaniment with Roger Kalia prior to the rehearsal on Sunday, June 21, 2026.*
- Submit a \$75 non-refundable application fee paid online at www.redlandsbowl.org or by check made out to **Redlands Bowl Performing Arts** and sent to 168 S. Eureka St. Redlands, CA 92373.
- Previous finalists of the Concerto Competition who have performed/competed at the Grand Finals are not permitted to apply.

***VIDEO RECORDING REQUIREMENTS**

The recording must show the applicant performing a concerto movement or piece for soloist and orchestra from memory. *Please perform the piece(s) you plan to audition with in person if you are selected for the Semi-Final Round. Play the whole movement with piano accompaniment.* The recording should be uploaded to a video sharing site such as YouTube. Please email video links to youngartists@redlandsbowl.org.

The video submissions will be reviewed, and **applicants will be contacted by March 30, 2026**, as to whether they will be invited to compete in the Semi-Finals in person on Sunday, April 19, 2026, at the University of Redlands. **Disclaimer: Decisions from the prescreening video auditions are final. We will not be providing notes or feedback.**

DATE AND LOCATION FOR SEMI-FINAL ROUND:

The Semi-Final Round will be held on **Sunday, April 19, 2026, from 4:00 pm – 9:00 pm** at the University of Redlands, Watchorn Hall (Loewe Auditorium), 1200 E. Colton Avenue, Redlands. **Please note: Each Semi-Finalist will perform a concerto selection of up to 15 minutes for a panel of judges.**

Assignment of Semi-Final audition time slot will be given on or before **March 30, 2026**. Please be present 30 minutes before your scheduled audition time. *Upon arrival, all entrants must check in at the registration desk for further instructions.* Once you perform for the panel of judges, you are welcome to leave. **Four finalists will be chosen from the Semi-Final Round to compete in the Grand Finals performance at the Redlands Bowl with orchestra on June 23, 2026.** *Two alternates are also selected in the chance that any of the four finalists are unable to perform.* The results will be posted online not later than 11:00 p.m. on Sunday, April 19, 2026.

COMPETITION REQUIREMENTS

Total Semi-Final Round time per contestant is up to 15 minutes. All selections must be memorized.

Instrumental repertoire must be a selection from a concerto or piece for soloist and orchestra, with available orchestrations. If the entire work/movement fits into the time limit, that is acceptable.

Please perform the piece(s) you would want to compete with at the Grand Finals with orchestra.

Applicants are permitted to audition with works for a standard orchestra, and generally the auditioned piece(s) may be performed at the Grand Finals. Finalists may be asked, however, to prepare a different piece from their listed repertoire to align with the Grand Finals orchestra configuration and/or due to programmatic considerations. Performance and music selections of finalists shall be subject to review and approval by RBPA competition management.

For pianists, it is not possible to practice on the piano on which you will perform for the Semi-Final Round. However, other pianos will be available for warm-up if needed.

Written comments from the judges will be e-mailed to contestants a short time after the round.

***** Accompanists are not provided for the Semi-Final Round. Each contestant must provide his or her own. Any associated expenses are the responsibility of the applicant. The only instruments provided by RBPA are pianos. Any other instruments needed are the responsibility of the applicant. *****
